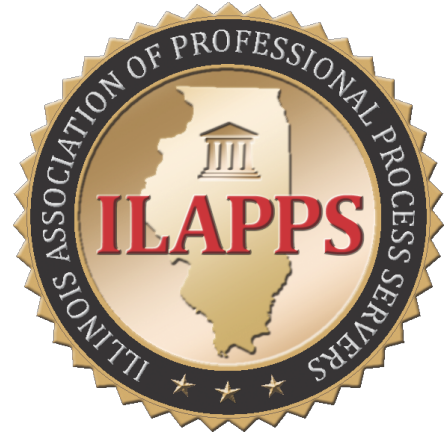

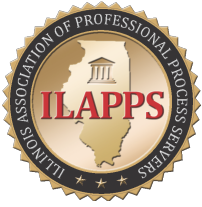

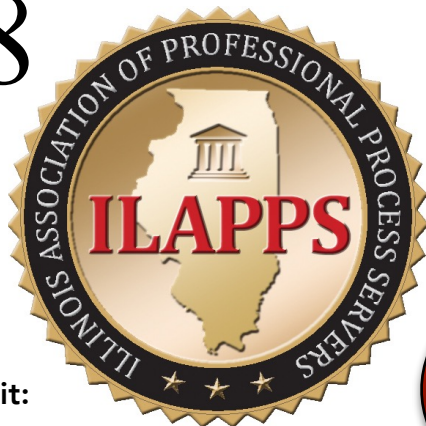

Founder of ILAPPS. In the early 90's Clutter's investigative skills helped free Rolando Cruz & Alejandro Hernandez in the infamous Jeanine Nicarico case in DuPage County, IL. In 2001 Clutter started the Illinois Innocence Project at the University of Illinois in Springfield. In 2004 his investigative work was cited by a federal judge who granted habeas relief to Randy Steidl. This case in Paris IL, was featured on CNN Death Row Stories & On the Case with Paula Zahn. In 2013 he started Investigating Innocence which is comprised of private investigators & criminal defense attorneys who work to free the wrongfully convicted.
